

## **Summary Rules & Participation Guidance for : [www.mywinninghome.co.uk](http://www.mywinninghome.co.uk) or [www.mywinninghome.com](http://www.mywinninghome.com)**

This document is intended to provide quick guidance only. Its content is to be read in conjunction with and is subject to the terms and conditions published on the website accessible via [www.mywinninghome.co.uk](http://www.mywinninghome.co.uk) or [www.mywinninghome.com](http://www.mywinninghome.com) (either "URL" accesses the same website) which take precedence.

1. The Promoted Party is Nationwide Research Corporation Limited, whose registered office is at Griffins Court, 24 – 32 London Road, Newbury, Berkshire RG14 1JX, trading under licence in the United Kingdom as Residential Development Institute™, Mortgage Research Institute™ and Mortgage Diary™.
2. Entry is restricted to one UK resident only per UK residential address, and such UK resident must be aged 21 or over and be a "Head" of the household at which they reside, such residence being the address with which they register and their main residence. Notwithstanding the aforementioned, persons connected with the Promoter and / Promoted Party are excluded from participation.
3. Persons eligible can enter at [www.mywinninghome.co.uk](http://www.mywinninghome.co.uk) and no purchase is necessary.
4. Registration and subsequently entered personal details and information supplied by participants must be materially accurate and where possible maintained thus, or entries may be or become invalid.
5. Entry is free to all promoted Draws ; Super Draws, Instant Draws, and others from time to time, and Registration can be finalised without a Promotion Code. Participants must ensure that the e-mail address they provide when registering is accurate and correct and they should check for and open, read and where appropriate respond to all e-mails sent to them from *Residential Development Institute*, or, *Mortgage Research Institute*.

7. The sooner a participant registers the more chances they have to win. The more free entries a Registrant enacts the better their chances of winning a prize.
8. Registrations finalised between 00: 00:01 hours on the 26<sup>th</sup> day of each month and 23:59:59 hours on the 25<sup>th</sup> of the month immediately following, have a Draw Date at the discretion of the Promoter between such date and the 15<sup>th</sup> of the month immediately thereafter.
13. The Close Date for the Promotion as a whole varies per Registrant and unless (at the sole discretion of the Promoter it is declared as arising sooner) shall be the 365<sup>th</sup> consecutive calendar day immediately following the date upon which each Registrant finalises their registration.
